संख्या प्रां 142592:—हरियाणा शहरी विकास प्राधिकरण अधिनियम, 1977 (1977 का अधिनियम 13) की धारा 54 के (ड.) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए तथा यादी क्रमांक 5/47/2016-2TCP दिनांक 9/11/2016 द्वारा सूचित राज्य सरकार के पूर्व अनुमोदन से हरियाणा शहरी विकास प्राधिकरण, इसके द्वारा, हरियाणा शहरी विकास प्राधिकरण (भूमि तथा भवन निपटान) विनियम, 1978 को आगे संशोधित करने के लिए निम्नलिखित विनियम बनाते हैं, अर्थात् :—

- 1. ये विनियम हरियाणा शहरी विकास प्राधिकरण (भूमि तथा भवन निपटान) संशोधन विनियम, 2016 कहे जा सकते हैं।
- हरियाणा शहरी विकास प्राधिकरण (भूमि तथा भवन निपटान) विनियम, 1978 में, विनियम 5 में, उप–विनियम (3) के स्थान पर, निम्नितिखत उप विनियम प्रतिस्थापित किया जाएगा, अर्थात् :-

"आवासीय प्लाट/भवन के मामलों में जब आवेदन इस प्रकार दिया गया है, सम्पदा अधिकारी या ऐसा अन्य अधिकारी जिसे सशक्त किया जाए, ऐसे निदेशों के अध्याधीन जो इस निमित्त प्राधिकरण द्वारा जारी किए जाएं, आवेदित आकार के प्लाट या भवन के आबंटन के लिए आवेदक को विचारा जाएगा। आबंटन "पहले आओ पहले पाओ" आधार पर या भाग्य—पत्रक (ड्रा आफ लाटस) द्वारा किया जा सकता है, जैसा प्राधिकरण द्वारा अवधारित किया जाए तथा सफल आवेदक को पंजीकृत डाक द्वारा या इलैक्ट्रोनिक ढंग से प्ररूप गाँ या "ग—1" या "ग—द" में आबंटन पत्र भेजा जाएगाः परन्तु शहरी सम्पदा को उचित आयोजना तथा विकास के प्रयोजन के लिए, भूमि तथा भवन, समूहों (प्रुप) या व्यक्तिगत के लिए या किसी पेशे का व्यवसाय करने वाले या कोई व्यवसाय, व्यापार या कारबार करने वाले व्यवितयों के लिए या व्यक्तियों के ऐसे अन्य प्रवर्ग, सरकारी विभागों तथा संस्थानों, धर्मार्थ संस्थानों तथा लोक कल्याण के अन्य संगठनों के लिए आरक्षित किया जा सकता है, जैसा समय—समय पर प्राधिकरण द्वारा निर्धारित किया जाए"।

- देय राशि के भुगतान में किसी चूक के मामले में, सम्पदा अधिकारी अधिनियम की धारा 17 के उपबन्धों के अनुसार शास्ति अधिरोपित करने तथा प्लाट को पुनर्ग्रहण की कार्रवाई करने के लिए अग्रसर होगा।
- अन्तरण की किसी अन्य शर्त का भंग करने की घटना में, सम्पदा अधिकारी अधिनियम की धारा 17 के उपबन्धों के अनुसार भूमि/भवन का पुनर्ग्रहण कर सकता है।
- 10. ऐसी भूमि/भवन या दोनों के विक्रय के कारण प्राधिकरण को देय ब्याज सहित सम्पूर्ण प्रतिफल धन राशि तथा अन्य राशि, यदि कोई हों, के मुगतान करने तक भूमि/भवन निरन्तर प्राधिकरण से सम्बन्धित होगा। आपको सक्षम प्राधिकारी पूर्व अनुमति के सिवाए प्राधिकरण को पूरी कीमत का भुगतान करने तक प्लाट/भवन के विक्रय, उपहार, गिरवी या अन्यथा के रूप में या उसके किसी अधिकार, हक या हित का अन्तरण करने का कोई अधिकार नहीं होगा।
- 11. प्लाट/भवन की अस्थायों कीमत के शत प्रतिशत मुगतान करने पर, आपको विहित प्रारूप में या ऐसी रीति में जो सम्पदा अधिकारी द्वारा निदेशित की जाए, हस्तान्तरण विल्लेख निष्पादित करना होगा। पंजीकरण तथा मुद्रांक शुल्क के प्रभार आप द्वारा भुगतान किए जाएंगे।
- 12. प्लाट/भवन उस प्रयोजन से इतर किसी अन्य प्रयोजन के लिए प्रयुक्त नहीं किया जाएगा जिसके लिए यह सक्षम प्राधिकारी द्वारा अनुमोदित योजना के अनुसार आबंटित किया गया है सिवाए समय-समय पर यथा संशोधित विनिमय 16 में यथा वर्णित फीस के भुगतान पर मुख्य प्रशासक की पूर्ण अनुज्ञा से भवन के निर्मित कवरण क्षेत्र की 25 प्रतिशत या 50 वर्ग मीटर, जो भी कम हो, की सीमा तक आवासीय प्रयोजनों के लिए भूमि/भवन के निपटान में गैर-उपद्रव व्यावसायिक परामशी सेवाएं दी गई हों। कोई भी हानिकर (आपतिजनक) व्यापार किसी मूमि/भवन में या पर नहीं किया जाएगा।
- आपके सक्षम प्राधिकारी द्वारा कथित भूमि/भवन पर अधिरोपित या निर्धारित सभी साधारण तथा स्थानीय करों, दरों या उपकरों का भुगतान करना होगा।
- 14. आपको आबंटन के समय पर आपके प्लाट में विद्यमान किसी निर्माण सामग्री, वृक्षों, संरचनाओं तथा संयुक्त (कम्पाऊण्ड) दीवार जिसका मुआवजा प्राधिकरण द्वारा निर्धारित किया गया है या भुगतान किया गया है, के लिए अलग से भुगतान करना होगा, यदि आप उसका प्रयोग करना चाहते हैं।
- 15. प्राधिकरण असमतल (उबड़-खाबड़) स्थलों को समतल कराने के लिए जिम्मेवार नहीं होगा।
- 16. (i) आपको भवनों के निर्माण को शासित करने वाले विनियमों के अनुसार सक्षम प्राधिकरण से प्रस्तावित भवन की अनुमोदित योजना प्राप्त करने के बाद कब्जा देने की तिथि के दो वर्ष के भीतर निर्माण को पूरा करना होगा। यह समय सीमा नीती के अनुसार विस्तार फीस प्रसारित करके सम्पदा अधिकारी द्वारा विस्तार योग्य है, अन्यथा यह प्लाट ग्रहण किए जाने के लिए देय होगा तथा उसके सम्बन्ध में भुगतान की गई सम्पूर्ण राशि या उसका भाग, यदि कोई हो, उन अधिनयम के उपबन्धों के अनुसार जब्त कर लिया जाएगा। आप सम्पदा अधिकारी की पूर्व अनुज्ञा के बिना किसी भवन का निर्माण या कोई परिवर्तन / परिवर्धन नहीं करेंगे। किसी भूमि या भवन का कोई भी विखण्डन अनुमत नहीं किया जाएगा।
- (ii) आपको कब्जा देने की तिथि के तीन मास की अधिकतम अवधि के भीतर प्लाट का कब्जा लेना होगा तथा दूसरे तीन महीनों के भीतर कम से कम नौ ईंच उंचाई की चार दीवारी भी निर्मित करनी होगी।
- 17. प्राधिकरण के पास समी ऐसे अधिकार तथा शिवतयों सिहत उवत स्थल में या के अधीन सभी खान तथा खिनज के लिए अधिकार आरक्षित है जो किसी सतह या किसी भूमिगत कार्य करने की शिवत सिहत तथा कथित स्थल का सारा या उसके किसी भाग की सतह को नीचे करने के लिए तथा गढ़े खोदने, भवन बनाने, लाईने निर्मित करने तथा साधारणतः उपयुक्त हो सभी ऐसी कार्यवाई करने के प्रयोजन के लिए उवत स्थल की सतह का प्रयोग करने सिहत सभी समयों पर उसकी खोज करने, कार्य करने, प्राप्त करने, हटाने तथा उपभोग करने के प्रयोजन के लिए आवश्यक तथा समीचीन हो जैसा प्राधिकरण उचित समझे जो उसमें दिए गए अपवादों तथा आरक्षणों के पूर्ण उपभोग के लिए सुविधाजनक या आवश्यक हो :

परन्तु आबिटिती ऐसे कार्यों या कार्य करने या किराए पर देने से कथित भूमि की सतह का प्राधिकरण द्वारा अधिभोग तथा सतह या भवन को हुई क्षति के लिए ऐसे भुगतान प्राधिकरण से प्राप्त करने के लिए हकदार होगा जो प्राधिकरण तथा आबंटिती के बीच सम्मत हो तथा ऐसे करार में असफल होने पर मध्यस्थता के संदर्भ से पता लगाया जाएगा।

- 18. प्राधिकरण इसके अधिकारियों तथा कर्मचारियों के माध्यम से कथित भूमि/उस पर बनाए गए भवन के किसी भाग में तथा पर लिखित में चौबीस घण्टे के नोटिस के बाद सभी युक्तियुक्त समयों पर तथा युक्तियुक्त रीति में यह पता लगाने के प्रयोजन के लिए प्रवेश कर सकता है कि आवंटिती ने उक्त अधिनियम के अधीन लागू नियमों/विनियमों के अधीन पालन की जाने वाली शर्तों का विधियत पालन तथा अनुपालन किया है।
- 19. प्राधिकरण को अपने अधिकारियों या कर्मचारियों के माध्यम से सभी समयों पर सभी कार्य करने के पूर्ण अधिकार, शक्ति तथा प्राधिकार होगा जो कथित भूमि∕भवन पर प्रथम प्रभार के रूप में, ऐसे सभी या कोई कार्य तथा बातें करने की लागत तथा उससे सम्बच्धित या उसके सम्बच्ध में तथा किसी रूप में उपगत सभी लागत के रूप में उस पर अधिरोपित सभी या किहीं निबन्धनों, शर्तों तथा आरक्षणों सहित अनुपालन लागू करने तथा उससे वसूल करने के प्रयोजन के लिए आवश्यक तथा सभीचीन हो।

20. इस आबंटन के विषय में से उत्पन्न या उसके सम्बन्ध में किसी भी प्रकार से उत्पन्न सभी विवादों तथा मतमेदों को मुख्य प्रशासक या उस द्वारा नियुक्त किसी अन्य अधिकारी को एक मात्र मध्यस्थता के लिए निर्दिष्ट किया जाएगा। ऐसी नियुक्ति पर कोई आपित नहीं होगी कि इस प्रकार नियुक्त मध्यस्थ सरकारी कर्मचारी है या प्राधिकरण का अधिकारी है कि वह उस मामले से सम्बन्धित था जिससे यह आबंटन ऐसे सरकारी कर्मचारी या अधिकारी, जैसी भी स्थिति हो, उसकी कार्य के दौरान से सम्बन्धित है, उसने विवाद या मतमेद के सभी या किन्हीं मामलों में अपने विचार व्यक्त किए हैं। ऐसे मध्यस्थ का निर्णय अन्तिम होगा तथा सम्बन्धित पार्टियों पर बाध्य होगा।

21. देय तिथि तक इस आबंटन पत्र के खण्ड 4 तथा 7 के अधीन यथा उपबन्धित अस्थायी कीमत / बढ़े हुए मुआवजे का मुगतान करना अनिवार्य है। यदि अस्थायी कीमत बढ़े हुए मुआवजे का भुगतान देय तिथि को नहीं किया जाता है, तो साधारण या चक्रवर्ती ब्याज जो समय–समय पर प्राधिकरण द्वारा निर्णीत ऐसे विलम्बित भुगतानों पर प्रभार्य होगा चाहे ऐसे विलम्बित भुगतानों पर प्रभार्य होगा चाहे कब्जा दिया गया है या नहीं। इस समय ब्याज की दर 15 प्रतिशत प्रतिवर्ष (साधारण) है।

भविष्य में, आपको समय—समय पर प्राधिकरण द्वारा यथा निर्णीत ऐसे विलम्बित भुगतानों पर साधारण या चक्रवर्ती ब्याज का भुगतान करना होगा। यह अधिनियम की धारा 17 के अधीन कार्रवाई करने के लिए प्राधिकरण के अधिकारों पर प्रतिकूल प्रभाव डाले बिना है।

- टिप्पण :-- (i) उपरोक्त आबंटन इस शर्त के अध्याधीन भी है कि आपको योजना की विवरणिका में यथा अधिसूचित शपथ पत्र प्रस्तुत करना होगा।
 - कार्यकारी मजिस्ट्रेट द्वारा विद्यिवत साक्ष्याकिंत शपथ पत्र तथा दो नवीनतम फोटो एवं तीन नमूना हस्ताक्षर प्रस्तुत किया जाएगा।
 - (iii) पते में किसी परिवर्तन को रजिस्टर्ड पावती डाक द्वारा सूचित किया जाएगा।
 - (iv) आबंटन से सम्बन्धित मामले के बारे में विवाद, यदि कोई हो, का निपटान हुड्डा के सम्पदा कार्यालय....... की अधिकारिता में किया जाएगा।
 - (v) यदि आप द्वारा प्रस्तुत आमदनी के सबूत/शपथ पत्र/प्रमाण पत्र किसी चरण पर मिथ्या के रूप में पाए जाते हैं, तो उपरोक्त आबंटन रदद हो जाएगा तथा जमा राशि प्राधिकरण के पास जब्त हो जाएगी तथा आपको उसके लिए किसी प्रकार का दावा करने का कोई अधिकार नहीं होगा।

No. Auth. 142592:— In exercise of powers conferred by clause (e) of Section 54 of the Haryana Urban Development Authority Act, 1977 (Act 13 of 1977) and with the previous approval of the State Government, conveyed vide memo No. 5/47/2016-2TCP dated 09.11.2016, the Haryana Urban Development Authority hereby makes the following regulation further to amend the Haryana Urban Development Authority (disposal of Land and Buildings) Regulations, 1978, namely:—

- These regulations may be called the Haryana Urban Development Authority (Disposal of Land and Buildings) Amendment Regulations, 2016.
- 2. In the Haryana Urban Development Authority (Disposal of Land and Buildings) Regulations, 1978, Sub Regulation (3) of the Regulation 5 shall be substituted with the following provision:
- "In the case of residential plot/building when the application has been so tendered, the Estate Officer or such other officer as may be empowered, shall subject to such directions as may be issued by the Authority in this behalf consider the applicant for allotment of a plot or building of the size applied for. The allotment may be on 'first come first served' basis or by draw of lots, as may be determined by the Authority and the successful applicant shall be sent allotment letter in form 'C' or 'Cl' or 'C-R' by registered post or electronic mode; provided that for the purposes of proper planning and development of an urban estate, land or building may be reserved for groups or individuals or for persons practicing any profession or carrying on any occupation, trade or business or for such other category of persons, Government Departments and Institutions, charitable institutions and other organizations of public welfare, as may be decided by the Authority from time to time."

- The possession of the plot will be offered within a period of 3 years from the date of allotment after completion of development works in the area. In case possession of the plot is not offered within the prescribed period of 3 years from the date of allotment, HUDA will pay interest @ 9% (or as may be fixed by Authority from time to time) on the amount deposited by you after the expiry of 3 years till the date of offer of possession. Development works for this purpose shall mean provision of basic amenities i.e. road upto WBM level, water, electricity and sewerage.
- 7. The above price is tentative to the extent that any Enhancement in the cost of land awarded by the Competent Authority under the Land Acquisition Act shall also be payable proportionately as determined by the Chief Administrator. The additional price determined shall be paid within 30 days of its demand.
- 8. In case of any default in payment of the due amount, the Estate Officer shall proceed to take action for imposition of penalty and resumption of plot in accordance with the provisions of Section -17 of the Act.
- In the event of breach of any other condition of transfer, the Estate Officer may resume the land/building in accordance with the provisions of Section 17 of the Act.
- 10. The Land/building shall continue to belong to the Authority until the entire consideration money together with interest and other amount, if any, due to the Authority on account of sale of such land/building or both is paid. - 11. On payment of 100% of the tentative price of the plot/building, you shall execute the Deed of Conveyance in the prescribed form and in such manner, as may be directed by the Estate Officer. The charges on registration and stamp duty will be paid by you.

The plot/building shall not be used for any purpose other than that for which it has been allotted in accordance with the plans approved by the Competent Authority except for rendering non-nuisance professional consultancy services in land/building disposed of for residential purposes to the extent of 25% of the built- up covered area of the building or 50 square meters, whichever is less, with the prior permission of the Chief Administrator on payment of fees, as mentioned in Regulation 16 and amended from time to time. (i) You will have to complete the construction within two years of the date of offer of possession, after getting the plans of the proposed building approved from the competent authority in accordance with the regulations governing the erection of buildings. This time limit is extendable by the EstateOfficer by charging extension fees as per policy, otherwise this plot is liable to be resumed and the whole or part of the money paid, if any, in respect of it forfeited in accordance with the provision of the said Act. The Authority may by its officers and servants at all reasonable times and in a reasonable manner after twenty four hours notice in writing, enter in and upon any part of the said land/building erected there on for the purpose of ascertaining that the allottee has duly performed and observed the conditions to be observed under the Rule/Regulations applicable under the said Act.
- 19. The Authority shall have full rights, power and authority at all times to do through its officer or servants, all acts and things which may be necessary or expedient for the purpose of enforcing compliance with all or any of the terms, condition and reservations imposed and to recover from you as first charge upon the said land/building, the cost of doing all or any such act and things and all cost incurred in connection there-with or in and any way relating there to.
- 20. All disputes and differences arising out of or in any way touching or concerning this allotment whatsoever shall be referred to the sole arbitration of the Chief Administrator or any other officer appointed by him. It will not be an objection to such appointment that the arbitrator so appointed is a Government servant or an officer of the Authority that he had to deal with the matter to which this allotment relates in the course of his duties as such Government servant or officer as the case may be, he has expressed his views on all or any of the matters in dispute or difference. The decision of such arbitrator shall be final and binding on the concerned parties.
- 21. The payment of tentative price /enhanced compensation as provided under clause 4 & 7 of this allotment letter, by due date, is mandatory. In case, payment of the tentative price /enhanced compensation is not made on due date, interest, simple or compound as decided by the Authority from time to time shall be chargeable on such delayed payments irrespective of the fact whether the possession has been offered or not. Presently rate of interest is 15% per annum (simple).

In future, you shall have to pay the interest simple or compound on such delayed payments as decided by the Authority from time to time. This is without prejudice to the rights of Authority to take action under Section 17 of the Act.
