- 2. It is to inform you that on the basis of enhanced compensation awarded by the Hon'ble ADJ and Supreme Court vide order dated 12.05.1993 and 10.12.2014 pertaining to the acquired land for the development of Sector-59, Faridabad, the recovery rate of additional price (2nd EC) has been worked out @ Rs. 668.55 Per Sq.
