The Special Grade Secretary so promoted should exercise his option before the Head of office concerned as provided in Para 49 of the G.O. (P) 145/06/Fin. dated 24.03.2006 within one month.

In the order read as 4<sup>th</sup> paper above Government had ordered that employees possessing the requisite language qualification could be considered for promotion to higher post in the office situated in areas where the predominant language in Tamil or Kannada even though such officers may not eligible for promotion in the order of Seniority.
